■ WATER

Three-day supply, one gallon per person per day.

■ TOOLS

Flashlight, extra batteries, manual can opener, battery-powered or hand-crank radio, NOAA Weather Radio with tone alert.

■ FIRST AID KIT AND PRESCRIPTIONS

First aid supplies, hand sanitizer and at least one week's supply of prescriptions and medications for the family.

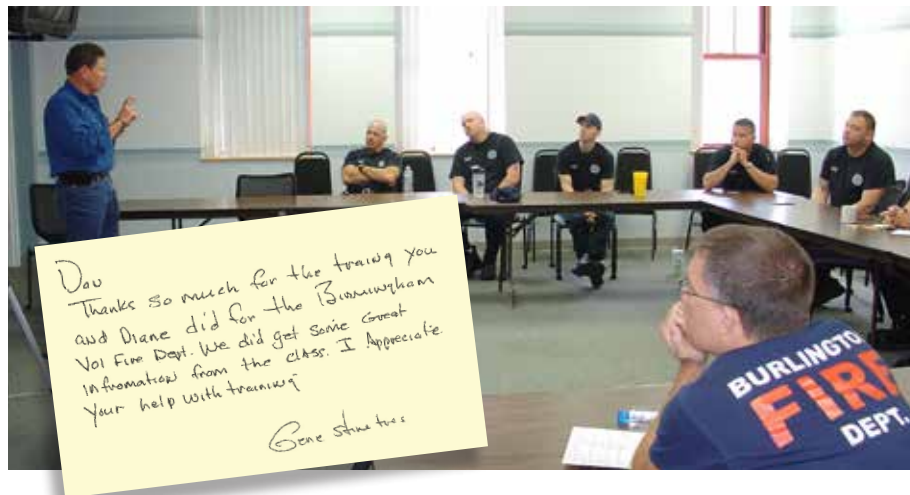
Area emergency professionals talk safety

One of the most important parts of the Access Energy Cooperative mission statement is safety. And one of the core principles on which we were founded is commitment to community. Access Energy Cooperative has teamed up our mission with our principles and formulated our commitment to providing safety education to our communities wherever possible.

As part of this commitment, Access Energy Cooperative safety director Daniel Philips has been working with area firefighters and first responders to bring them up-to-date on how to handle emergency situations involving electricity. They've been

working together as a team to talk about emergency action plans and how to handle electrical energy during

emergency situations. Philips also has been presenting general electrical safety information to them. ⚡



Access Energy Cooperative scholarships awarded

Six area high school graduates recently were named recipients of \$1,500 scholarships from Access Energy Cooperative. In 2017, the Access Energy Cooperative Board of Directors increased the cooperative awards from three \$500 scholarships to six \$1,500 scholarships each year, two in each of its three districts. The parents or guardians of the applicant must be members of Access Energy Cooperative. Winners are chosen based on their academics, achievements, community involvement, and a submitted essay.

FROM THE BOARD

Dividends are coming!

Once a satisfactory level of margins or profits for 2016 was determined by the Access Energy Cooperative Board of Directors, the cooperative assigned the rest of the margins to you, the members – each of whom owns a portion of the cooperative – according to the amount of energy purchases you made in 2016.

Each member has a dividend account at the cooperative where your dividend allocations accumulate. When the board allocated the 2016 margins, your portion was moved to your dividend account. Notices were mailed May 15 with the amount that was allocated to your account.

This year Access Energy Cooperative allocated \$1,406,583 and passed through allocations from NE Power of \$854,293, for a total allocation of \$2,260,876.



The amount of total allocations the cooperative has stored in the dividend accounts was then reviewed by the Board of Directors to determine whether or not to generate a dividend payment this year. After reviewing the cooperative's current financial position, the Board approved a dividend refund this year in the amount of \$975,818. This refund is 40 percent of the remaining dividends for 1997, 59 percent of 2001, 25 percent of 2002, 18 percent of 2003 and 11 percent of 2016.

Dividend checks will be available to pick up at the annual meeting on August 1. Any checks not picked up will be mailed after the annual meeting to the most current address we have on file. The cooperative won't be printing checks for amounts under \$5; these amounts will be added to next year's refund. ⚡
